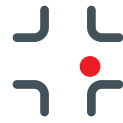

What is ShotSpotter?

Police rely on the community to call 9-1-1 if gunshots are fired, but only 20% of incidents are ever reported on average. This creates a situation where police departments have a large data gap that makes it difficult to be able to effectively “serve and protect” when it comes to gun violence. SoundThinking’s ShotSpotter acoustic gunshot detection technology fills the gap with a network of acoustic sensors that can detect, locate, and alert police to nearly all outdoor gunshot incidents. The system is in operation in more than 150 cities and is used by police to:

- Respond to a higher percentage of gunfire incidents;
- Improve response times to crime scenes to better aid victims and find witnesses; and
- Help police locate key evidence to identify and investigate suspects.

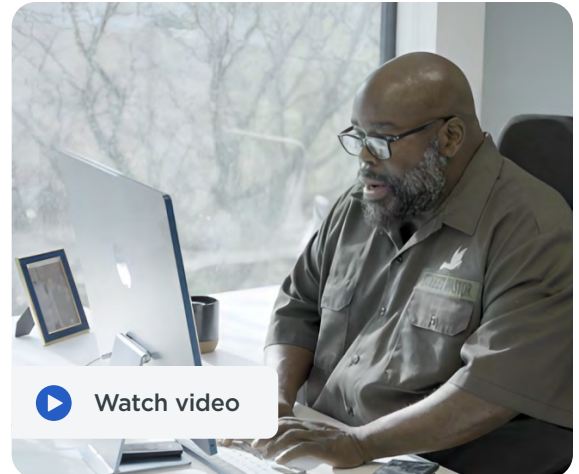

Minutes Matter for Victims

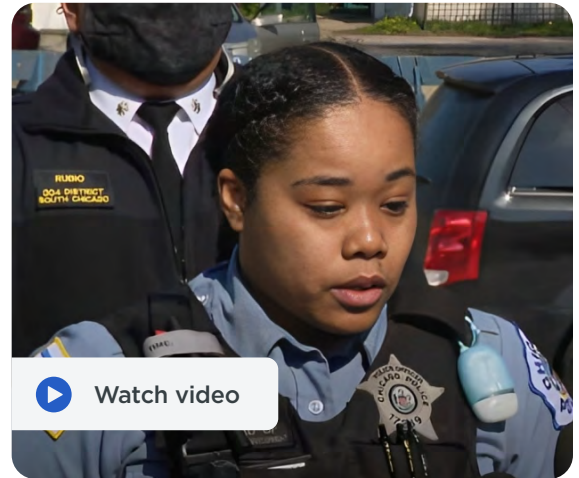
On April 26, 2021, Officers Rhonda Ward and Julius Givens were first on scene in the 8200 block of South Cole Ave. for a ShotSpotter alert.

Officer Ward found 13-year-old Swayzee Rankins shot in the back and abdomen. The officer immediately put the boy in the squad car and drove him to the hospital.

“Stay with me and we’re gonna make this trip together and he trusted us,” Officer Ward said. *“Stay with us and he did just that. So he’s a hero too.”*

The family told WGN News that Rankins and his 14-year-old friend were shot while walking home from a friend’s house.

WGN News reported that at the time of the story Rankins was in critical condition, but the family said he was going to be okay.

CWB Chicago reported on a suspect allegedly welcomed the new year by firing 80 rounds into the air using three firearms. SoundThinking's technology detected the gunfire and alerted the Chicago police, who responded to the scene at the man's residence. The police discovered spent shell casings, firearms, and a significant amount of suspected methamphetamine in his possession. The man faces charges of reckless discharge of a firearm along with numerous other felonies.

[Police Arrive at Sunday Shooting 60 Seconds After ShotSpotter Alerts Them, Find Injured Woman](#)

In the second incident in its first week on the job, Pasadena's new ShotSpotter gunfire detection system sent officers to the scene of a shooting Sunday afternoon where they found an injured victim. The ShotSpotter system detected and immediately reported 18 gunshots, Pasadena police Lt. Monica Cuellar said. Officers on patrol were instantly notified and arrived at the scene of the shooting within 60 seconds.



[Ersie Joyner 'humbled and humanized' after surviving 22 bullet wounds in Oakland shootout](#)

According to Joyner, police arrived before any human had called 911. Joyner says he never lost consciousness and saw Oakland police cars roll up quickly, despite not hearing any witnesses call police. Shortly after Joyner had been shot, his daughter texted Ralph Clark, CEO of ShotSpotter. "Hey thank you so much, Ralph," she wrote. "We think ShotSpotter might have played a role in saving my dad's life."
